CONFIRMATION OF THE REGISTRATION: The application is followed by the phase by the competent office (settore Servizi Educativi, Istruzione e Sport – Ufficio Scuole dell'Infanzia for the municipal schools) which analyzes the requests, confirming them or changing the destination according to the criteria established by the regulations. In the period May-June families will receive via mail - or by post for families who did not communicate their email address - notice of payment of pre-enrollment fee, together with the confirmation of enrollment in **State and Municipal schools**. This non-refundable fee relates to a portion of coverage for municipal charges deriving from the costs for organizing services incurred in support of kindergartens. The cost of the meal - not divisible and including breakfast / lunch / snack - is determined on the basis of the ISEE indicator. Contextually to the confirmation, families will receive a specific circular concerning the determination of the meal cost and the payment methods.

ADMISSION CRITERIA

- valid for municipal schools. State schools may have different criteria in declination and order -

- 1. Priority to second child entering the same kindergarten as the first child attending second year;
- 2. Zoning
- 3. Age (priority to older children)
- 4. Presence of siblings attending the same school complex or next degree adjacent complexes (primary and lower secondary schools)
- 5. Parents' job: time schedule and working place;
- 6. ISEE declaration (priority to minor indicators)

Regarding criterion n. 2, "zoning", the Municipal Administration defines the catchment area for each school.

In the event that the places available in each kindergarten are greater than the number of children living in the indicated catchment area, the Kindergarten Office (Ufficio Scuole dell'Infanzia) will proceed to expand the indicated area until all places are allocated.

Once the zoning criterion is applied, children entitled to be welcomed in schools where there is an excess of applications from residents in the area, will be admitted in Municipal kindergartens with availability, even if not requested when applying for enrollment.

Children who have - on 31th August - their registered residence or domicile at the address indicated in the application are considered as belonging to the school's catchment area. The same applies to those who can demonstrate, within a short time, the actual transfer with the deed of purchase or lease. Applications received after the deadline may be examined only after the admission of all children for whom a regular application has been submitted.

VACCINATION OBLIGATION

In compliance with the provisions of Law no. 119 of 31/07/2017, children must have been previously vaccinated in order to access educational services. The Municipal Administration follows the verification procedure indicated in the MIUR circular no. 14659 of 13/11/2017.

KINDERGARTEN. FOR FURTHER INFORMATION...

Kindergarten perhaps no longer needs special presentations. It is a school that has reached full educational and didactic maturity and is attended by almost all children aged three to six. Children of this age need to broaden their experience, to establish an active and pleasant relationship with people, things, the reality that surrounds them. This is a particularly fruitful age for learning, for the search for autonomy, for the construction of identity. The kindergarten can offer, in collaboration with families, a fundamental contribution to enhance the originality of each child, his autonomy, his potential for knowledge and expression. In kindergarten, particular attention is paid to the relationship with families, in order to build together the best conditions for the attendance of children and their active participation in the educational experience.

In Cesena, preschools are present throughout the territory and are well equipped to give a positive response to the needs of play, socialization, cognitive and emotional growth of children, and to offer parents a new opportunity to perform at their best.

Kindergartens are open to children from mid-September to June 30th of the following year. In July, children whose parents work can attend summer camps organized by the Municipality, according to the procedures that will be defined in the appropriate public notice. Applications for this service are usually open starting from April-(information at Ufficio nidi e scuole infanzia del Comune).
